While there are many functions in the smart contract code of many other Cryptocurrencies that allow the owners of cryptocurrencies to own valuable assets of the common people and to the detriment of investors; on the other hand in rISO Coin Various important steps have been taken to make it 100% safe from such errors.



Not only rISO Coin's smart contract is audited, but all the functions in rISO Coin's contract are designed to make rISO Coin 100% the most secure digital currency, and Decentralized finance has been made 100% secure for the people.

While keeping this in mind, the ownership of rISO Coin's smart contract, which is deployed to the Binance Smart Chain, has been renounced so that no one can change its functions in the future. In other words, no individual, organization, entity, or group in the world is going to control rISO Coin and neither will it.

WHY AND HOW DOES THE COMMUNITY WON THE RISO COIN?

Further clarification regarding the RISO Coin team

There are many risks involved in other cryptocurrencies. We understand this and have the skills, experience, and leadership to overcome them.

The basic and important role of any cryptocurrency is its supply; the one who has the most supply of the Cryptocurrency is the real owner of the Cryptocurrency.

It is not necessary that the person or group who has developed or launched a cryptocurrency is the owner of it, but the real owners of any cryptocurrency are only the people who have a huge amount of supply. Because the one, who has the most supply, actually owns the assets of all the investors in the liquidity pool, he can seize people's assets by selling his supply if he wants.

Whenever an investor buys any cryptocurrency, his asset goes into the liquidity pool and in return, the buyer is given cryptocurrency coins and according to the principle of demand and supply that is why the value of coins also increases. On the other hand, if someone sells cryptocurrency, the coins sold go back to the liquidity pool and in return, the seller gets the assets back from the liquidity pool. That is, all the assets of the buyers of cryptocurrency go to the liquidity pool and the one who has the most supply is the owner of the assets in this liquidity pool and he is the one who controls the price of the cryptocurrency. This is a very important issue and only RISO Coin presented a solution to this problem.

RISOCoin has a supply of 7 Billion which cannot be increased and 100% of its supply is owned by no one but the community.

That is, only investors own the assets in the liquidity pool. Apart from investors, no one has a supply of RISOCoins.

That is why RISO Coin has no owner other than the investors. RISO Coin is a 100% community-driven Digital Currency because the entire supply of RISO Coin is in the hands of the Community, the Developers of RISO Coin have 0% supply of RISO Coin. RISO Coin does not have a developer's wallet that has supplies.

This is the main reason that makes RISO Coin unique and secure from all other cryptocurrencies. Even RISO Coin is more secure than Bitcoin.

TRANSPARENT

All transactions are recorded on a global public ledger called the blockchain. The ledger is updated at regular intervals in blocks that are connected to form a chain. This allows anyone to easily see the full history of ownership and helps to eliminate the potential for fraud.

What is RISO Coin used for?

Thanks to its low transaction fees and fast confirmation times, there will be a growing number of use cases for RISO Coin. These range from games that integrate RISO Coin payments, to social networks and publishing platforms that allow you to tip using RISO Coin.

There are several use cases of RISO Coin, but we will focus on some of the financial-related cases.

INTERNATIONAL PAYMENTS

RISO Coin can make international payments faster and cheaper. Since RISO Coin is not issued by a central authority and is effectively borderless, you can bypass the several intermediaries needed to process the transaction. Transactions can happen on the same day safely and securely without any verifications by any central authorities, Banks

ALTERNATIVE BANKING AND WORLDWIDE PAYMENTS

A decentralized financial system democratizes finance and gives the unbanked access to services that a traditional financial institution would deny based on existing standards. In emerging markets, those outside the banking ecosystem are using mobile phones to access cryptocurrencies, as it's a viable alternative to a bank account and a way to protect their money from hyperinflation.

INVESTMENTS

RISO Coin has a limited and finite supply of coins, giving it the ability to keep inflation low. This stipulation encourages some retail and institutional investors to view RISO Coin as a store of value and invest in it as a form of "digital gold."

LONG-TERM STORE OF VALUE

The total supply of RISO Coin will never exceed 7 Billion coins. This is written into the code that defines the RISO Coin protocol.

As a decentralized network, RISO Coin users ultimately decide how the protocol evolves - and since it is not in the interests of participants to dilute their holdings by changing the protocol, the 9-million-coin limit will almost certainly remain in place forever.

RISO Coin's 'set-in-stone' supply schedule makes it unique among hard assets. By comparison, the supply of gold, although limited, is nevertheless subject to the forces of supply and demand. As the price of gold rises, more gold miners are incentivized to search for gold. This leads to an increase in the supply of gold, which places downward pressure on the price.

HIGHLY EFFECTIVE MEDIUM OF EXCHANGE

RISO Coin enables peer-to-peer payments between individuals - just like cash, but in the digital realm. Critically, fees for sending RISO Coin typically amount to less than a penny per transaction, and settlement occurs near-instantly, regardless of the physical location of participants. This makes RISO Coin useful for not only remittances and cross-border trade, but also for daily transactions like buying groceries. Since the fees and transaction times are so low, RISO Coin is also effective for micro-transaction use cases like tipping content creators and rewarding app users.

RISO(DAPP & DEX) DECENTRALIZED EXCHANGE

In the future, we will build a decentralized swap (DAPP) and exchange (DEX), where RISO Coin will be used as one of the key base assets as well as gas to be spent.
